**Ingredients:** Lentils\* 46%, tomato pulp\* 30%, water, onion\*, extra virgin olive oil\*, sea salt, pepper\*, bay leaf\*. \* Organic

**Description of the processing process:** cleaning and soaking lentils. Cooking with other ingredients, potting, sterilization, labeling.

**Primary packing:** Glass jar 300g, jar 314 Simply /capsule 70mm flip green.

## **Palletizing:**

Thermo packs of 6pcs. Packages per layer: 21. Number of layers: 10 Total packages: 210. Total glazing: 1260.

**Minimum storage period:** 36 months from the date of production. Expiration date expressed in

days/month/year.

Platform weight: euro pallet 120x80x110h gross weight Kg 644.

Allergens contained and possible cross-contamination: Cereals containing gluten.

**GMOs:** the product is free from contamination by Genetically Modified Organisms.

**Tips for proper storage:** store in a cool and dry place away from light and heat sources.
